Kathy Davis' commitment to our program began when she graduated in 1991. Since then, she has served the department, Alumni


Association, APTA, community and the profession in many ways.








Gelebrating a Milestone

Editor's Note: On Oct. 23, 1997 Bobbie di Sabatino was rushed to the hospital with an acute heart condition. At the time, she was not expected to live through the weekend. Although Bobbie remains hospitalized, she is in good spirits. Unfortunately, due to her condition, Bobbie was forced to make a difficult decision. As of Jan. 1, Bobbie is officially retired from the department where she worked for 30 years.

On Aug. 14, 1997, Bobbie di Sabatino celebrated her 30th year of working in the University of Maryland's physical therapy department. The people with whom she's worked have become her second family.

All she wanted was a new washer and dryer; she hadn't bargained on also finding a lifetime career. When Bobbie di Sabatino came to work in the physical therapy department in 1967, she planned to work for one year, just long enough to purchase a new washer and dryer and to have a little bit of money left over. Once she began working here, however, she was hooked. Thirty years (and many appliances) later, Bobbie remembers exactly what made her want to stay.

"The department was just like a big family. The faculty, the department chairs, the secretaries with whom I've worked have been absolutely marvelous," says Bobbie. "You spend more waking time with your co-workers than you do with your own family. The people I work with have become my second family."

Over the years, Bobbie has seen more than 1,300 students graduate, has worked in a number of buildings, and has seen two department chairs come and go. For the past 12 years, she has worked as the executive administrative assistant to department Chairman Dr. Clarence Hardiman, who describes her as a "jack of all trades." He explains that Bobbie has done a little bit of everything from assist-

ing faculty and working on accreditation reports to helping with administration. And somehow, he says, she always meets even the most impossible deadlines.

"The thing about Bobbie is that you tell her what you want done, and somehow she does it!" says Dr. Hardiman.

Terry Heron, secretary for the Admissions Committee, has known Bobbie since Terry came to work for the department fresh out of high school 27 years ago. She and Bobbie are close friends and not only carpool together, but also go to lunch, dinner, alumni nights at the ballpark, and even family functions together.

"[Bobbie's] the type of person who sets the tone of the office. She just has such a comfortable way with herself that you know that she genuinely wants to help. It makes you feel at ease," Terry says. "It's good to have someone that is a friend and not just someone that you're putting your time in with."

Bobbie has been described as the "walking, talking, alumni directory." She and Terry often work the phonathon, and with their knowledge of alumni, they assist students with the pronunciation of alumni names, recall past students' nicknames, and reminisce about funny stories and good times. Bobbie's knowledge of the alumni also helped a great deal when she and Dr. Donald Hobart started the Alumni Association about 10 years ago.



"It started with just a handful of us doing everything," says Bobbie. "For so many years, I kept hearing students say, "Why don't we have an alumni association?" So Dr. Hobart and I put our heads together the best we could, [and] it took wings."

Steve Tepper '79 has kept in touch with Bobbie through the years. From 1980 to 1992, he taught in the physical therapy department, and he and Bobbie became close friends. Although he now teaches at Shenandoah University in Winchester, Va., Steve, Bobbie, and Terry still frequently get together. He believes that Bobbie is an irreplaceable part of the department as well as a good friend.

"[Bobbie is] the heart and soul of the physical therapy program. She is, in a lot of ways, one of the major forces that keeps the department going in a good direction," says Steve. "She is in touch with what the students and faculty are doing; she captures the history of the place along with everything that's good about it."

"I can't imagine the department without her," adds Judy Schank '73. Judy

works as a part-time home care therapist and is raising her children, but from 1983 to 1993, she taught in the department. She says that Bobbie is very supportive, and often helped her when she returned to teaching after her daughter was born.

"She's always willing to go the extra mile for the department, pitch in and do what needs to be done. And sometimes that meant an awful lot of her own time and energy," recalls Judy. "You can have someone who does their job and is good at it, but she does more than that. She goes that extra little bit to make somebody feel comfortable. Many days she held my hand and told me not to worry about things."

Bobbie says that one of the reasons that she's stayed at the university for so long is that she's a consistent person. "I was born in University Hospital. Little did I know I'd be back here working," she says.

Raised in East Baltimore, Bobbie attended Seton High School. She was married in 1960 and lived in Washington, D.C. for six months. Bobbie returned to Baltimore and bought a house in Rosedale, where she's lived for 35 years. Divorced in 1976, Bobbie has never re-married.

Bobbie enjoys spending her free timé/ with daughters Ann and Carman and her three grandchildren. She likes camping, gardening, walking and making crafts. While raising her own daughters, Bobbie also

helped to raise a friend of her daughters' who is now married with two children. Bobbie is close to her own mother and they often spend Sundays together, going to church, having dinner, and shopping.

After 30 years in the same department, there is one thing that Bobbie says makes her feel old. Three children of former graduates are now students in the program. "That's when you know you've been here a loooonnnggg time," she laughs. "We just say we're not getting older, we're getting better."

Though Bobbie intended to leave after one year, the department is glad she stayed.

As this issue went to press, we received news that Bobbie underwent heart transplant surgery on Feb. 13; she is currently in recovery and expected to go home soon. We will include a follow-up story in our next newsletter. Cards and letters can be mailed to:

Linda (Cyphers) French '85 and E. Tonas Kalil'85 are co-founders of a camp for children who are burn survivors.

When Linda and Tonas worked at the Baltimore Regional Burn Center, they sometimes felt that they weren't doing enough for the children they treated. Though they physically rehabilitated young burn survivors, Linda and Tonas believed that the children needed more.

"It's fine to provide excellent medical care and to save someone's life, but what did we offer them afterward?" asked Linda and Tonas. It didn't take long for them to find their answer.

In 1987, Linda attended the American Burn Association's conference and learned about the Denver Children's Hospital's burn camp. Linda was so impressed that she shared her enthusiasm with Tonas and Peggy Schmitt '69, their supervisor at the Burn Center. Linda suggested that the three of them start a camp. All agreed.

The following summer, Linda traveled with two children they had treated at the Burn Center to the camp in Denver to investigate how to start a camp near Baltimore. Upon their return, the planning began.

In 1989, Linda and Tonas held their first burn camp under the auspices of the Baltimore Regional Burn Center at a site on the Eastern Shore. For the next two years, they held the camp in Southern

Pennsylvania. In 1992, they decided to branch out.

With three years of experience under their belts, Linda and Tonas decided to incorporate the camp program and apply for non-profit status. The Mid-Atlantic Burn Camp was born. According to Tonas, "we wanted to have more control over the quality of the program and its future growth." They also wanted to open the camp to many different children through many different hospitals.

Each year, the Mid-Atlantic Burn Camp holds its program during the third week of August at Camp Horizons in the Blue Ridge Mountains of Virginia. The camp is staffed entirely by volunteers; even Linda and Tonas who work throughout the year, receive no compensation.

The activities at camp are age-appropriate and fall into two categories. There are traditional activities for younger children including swimming, horseback riding, arts and crafts, games, and nature programs. For older campers, adventure activities are available including rock climbing, caving, and river trips. Because the camp is for burn survivors, activities are geared toward addressing their specific needs.

"Linda and I firmly believe that simply getting a group of children together who are burn-injured does not a burn camp make," says Tonas. "We want to take this opportunity to allow them to open up about things that are important to them and expose them to new concepts, new possibilities in their lives that will help them adjust to their burn injuries."

Often, an adult burn survivor is a role model to the children and will lead discussion groups at camp. Burn injuries are isolating, and, as Linda says, children are often cruel to burn survivors. Burn Camp gives the children a chance to talk and

interact with others who understand how they feel.

The summer of 1998 marks the tenth year that Linda and Tonas have run a burn camp. Now, several young adults who were once campers are returning as counselors. In addition to physical therapists, counselors include occupational therapists, nurses, fire fighters, law enforcement officers, businessmen and women, and government employees.

Sue Pisani '98 was a counselor for the first time this past summer. "The camp is an ideal setting in which to work with kids. I had never done that before," she says. Sue was amazed at how the campers of all ages, races, religions and cultures all got along. The kids were just kids, she says.

"It is definitely one of the best experiences that I've had," states Sue. "That's why I have to return." Next year, her

husband is coming too.

Peggy Schmitt will return as well. When Linda and Tonas first operated the camp through the Burn Center, Peggy was unable to be a counselor due to job restrictions. In a different position as rehabilitation coordinator for The Lorien Frankford Rehabilitation Center, Peggy will be returning for a fifth summer as camp counselor.

"It's fun. It's a lot of hard work [but it's] a glorious fun time," says Peggy. "We have children climbing mountains who we thought would never be off ventilators."

The cost for sending a child to camp is about \$650, but campers pay nothing. Funding is provided by organizations, corporations, and individuals who sponsor children. The Burn Foundation, The Metropolitan Fire Fighters Burn Center Fund, the Aluminum Cans for Burned

Children, and an alliance of fire fighters who work with fire prevention programs send children from Philadelphia, Baltimore, Washington, D.C., and Tidewater, Virginia, respectively. Even the bus service for camp is donated by Gray Lines The Gold Line bus company. During

the year, administrative matters for the camp are operated from Linda's home—with an answering service donated by Focus Telecommunications.

Aside from Burn Camp responsibilities, Tonas works at Laurel Regional

Hospital as a physical therapist and teaches a continuing education class in burn rehabilitation. He and Linda work as consultants for the International Association of Fire Fighters and teach the Burn Rehabilitation Course at the University of Maryland's PT department. Linda also works as the weekend supervisor at Holy Cross Hospital and on an as-needed basis for Holy Cross and Johns Hopkins Home Care.

Do they sleep?

"It's optional," laughs Tonas.

Why do they keep doing it?

"It makes a difference," says Linda.

"I can make a difference in somebody's life, and I can change my little corner of the world."




